### REFUND Policy: Withdrawal

- 1<sup>st</sup> Week, refund = \$ 300.00
- 2<sup>nd</sup> Week, refund = \$ 250.00
- 3<sup>rd</sup> Week, refund = \$ 0.00

**Time Requirements:** Each student will be required to complete the state mandated 24 hours of classroom instruction and 24 hours of in-car instruction.

It is the **student's responsibility** to complete the state mandates for classroom as well as in-car instruction in order to obtain a certificate of course completion.

**Absences:** Absences from either classroom or in-car instruction must be made up. Additional fees may be imposed. Students contact their Driver Ed instructor to arrange make-ups.

**Approx. Start Date:** Week of January 30, 2012

**Approx. Finish Date:** Week of June 4, 2012

**Instructional Schedule:** The proposed schedule is tentative. Student enrollment and instructor availability will decide the final schedule. Preference for driving slots will be assigned using the student's birth date as the determining factor (preference given to the oldest students) for selecting a driving time.

**Class / Driving Cancellations:** In the event that classes or driving times are cancelled due to weather or other circumstances, students may have to make these up on alternate days. This will be announced by the instructor.

If they do not, they will be turned away and will be required to make a new road test appointment.
