Re: Local Government Exemption Impact Report

Section 495 of the New York State Real Property Tax Law (RPTL) requires counties, cities, towns and school districts to prepare and publicize a Local Government Exemption Impact Report as part of its annual budget process.

The exemption report should notate the total equalized assessed value on the assessment roll(s) by municipality and is required to identify the following:

- Every type of granted exemption by the statutory authority;
- The cumulative impact of each type of exemption expressed as either a dollar amount of assessed value or as a percentage of the total assessed value on the assessment roll;
- The cumulative amount expected to be received from individuals/entities as payments in lieu of taxes (PILOTs) or other payments for municipal services; and
- The cumulative impact of all exemptions granted.

The attached documentation provides information and data associated with the Tentative Assessment Rolls for the Town of Bethlehem and the Town of New Scotland for the Bethlehem Central School District in accordance with RPTL § 495. The May 1st Tentative Assessment Roll is the only assessment roll available for the Bethlehem Central School District for purposes of this requirement. The Final Assessment roll will not be available until July 1st which is a date after which it is anticipated that the budget process will be complete.

A summary of exemptions is as follows:

- Town of Bethlehem 4,965 exemptions for a total of \$729,850,983 in equalized assessed value:
- Town of New Scotland 559 exemptions for a total of \$45,724,776 in equalized assessed value;
- Total 5,524 exemptions for a total of \$775,575,759 in equalized assessed value.

The District's 2025-2026 tentative budget includes \$3,624,000 in estimated PILOT revenues to offset budgeted appropriations. Additional PILOT information can be located under exemption code 18020 in the Tentative Assessment Rolls.

While there may be changes in the number of exemptions and equalized assessed values between the Tentative and Final Assessment Rolls, changes to parcel numbers or assessed value are anticipated to be nominal.

Should members of the Board of Education have questions relating to the District's Local Government Exemption Impact Report, I can provide additional information or clarification at the next meeting of the Board of Education.
