7. I will never give personal information (full name, address, phone number, or my e-mail address, etc.) about myself or any other person when using the Internet.

Any violation of these regulations may result in loss of district-provided access to the Internet. Additional disciplinary action may be determined at the building level in keeping with existing procedures and practices regarding inappropriate language or behavior. When and where applicable, law enforcement agencies may be involved.
