The Bethlehem Central Physical Education Department offers an **Athletic exemption option for Physical Education**.

The program is for seniors only who are in good academic standing in Physical Education, meet the fitness standards of the fitnessgram assessment, and are members of two Bethlehem Central Varsity Sports in their senior year.

The Athletic exemption is for two season Varsity Athletes, which will exempt the student from Physical Education for the year. The program is pass/fail grading and will not count towards a student class ranking and GPA. They will also not be eligible for the Capital Zone of the New York State Association Physical Education Leadership Award.
